Sut mae trefnu asesiad ar gyfer Addasiad Sylweddol?

Gellwch ofyn am asesiad Therapydd Galwedigaethol drwy gysylltu gydag Adran y Gwasanaethau Cymdeithasol eich Awdurdod Leol.

Bydd asesiad yn penderfynu'r math o addasiad sydd ei angen, neu, fel arall, bydd y Therapydd Galwedigaethol yn eich cynghori ar y technegau gorau, offer a gwasanaethau i gwrdd gyda'ch anghenion.

Beth sy'n digwydd pe bai'r Therapydd Galwedigaethol yn argymhell Addasiad Sylweddol?

Mae'r cais yn cael ei gyflwyno i Banel Addasiadau CCG. Bydd y Panel Addasiadau, wedyn, yn argymhell y datrysiaid mwyaf priodol i gwrdd gyda'ch anghenion.

Yn ogystal ag asesiad gan y Therapydd Galwedigaethol cyn y Panel Addasiadau, efallai bydd aelod o'r Tîm Gwasanaethau Tenantiaeth yn ymweld â chi i asesu eich sefyllfa adref/teulu. Bydd y Tîm Gwasanaethau Tenantiaeth yn cynnig cyngor o safbwynt tai ac yn ateb unrhyw gwestiynau sydd gennych o bosib o ran eich cais am addasiad.

Gwneud Cais am Addasiadau

Beth sy'n digwydd pe bai'r cais am Addasiad Sylweddol yn cael ei gymeradwyo?

Bydd y Panel Addasiadau yn cadarnhau eu penderfyniad i gymeradwyo'r cais drwy lythyr. Pe bai gofyn i chi dalu tâl gwasanaeth, bydd disgwyl i chi gwblhau a dychwelyd y 'Ffurflen Tâl Gwasanaeth Addasiadau' sydd wedi'i gynnwys gyda'r llythyr yn cadarnhau'r penderfyniad. Unwaith bydd y ffurflen wedi ei ddychwelyd, bydd CCG yn trefnu arolygwr/contractwr i ymweld â'ch eiddo i asesu'r gwaith sydd angen ei wneud. Bydd CCG wedyn yn prynu'r offer addasiadau, a bydd dyddiad cyfleus ar gyfer gosod yn cael ei drefnu.

Making a Request for Adaptions

If you or anybody living in your home has a disability or health concern that means you have problems going out, difficulty in moving about or carrying out everyday tasks safely in your home, then Cartrefi Cymunedol Gwynedd (CCG) may be able to help.

What is an Adaptation?

An adaptation is a physical alteration to your home which helps you get in and out of your home, improves mobility within your home and allows you to have safe access to essential facilities in the main areas of your home. There are two types of adaptations; a Minor Adaptation and a Major Adaptation.

Minor Adaptations

Examples of Minor Adaptations include:

- Grab rails
- Mop stick rails
- Key safe
- Half steps
- Extra lighting

Major Adaptations:

Examples of Major Adaptations include:

- Stairlift
- Walk in shower
- Wet room
- Ramp
- Widening doorways

These adaptations will require an assessment and a recommendation from an Occupational Therapist (OT).



Please Note:

If you receive an adaptation that requires servicing and maintenance (such as a stairlift, though floor lift or ceiling track hoist etc), you will be required to pay a weekly service charge. Please see the 'Adaptations Service Charge Factsheet' for more information on service charges.

How do I get an assessment for a Major Adaptation?

You can request an OT assessment by calling your Local Authority's Social Services Department.

An assessment will determine the type of adaptation you need. Alternatively, the OT will advise on the best techniques, equipment and services to meet your needs.

What happens when the OT recommends a Major Adaptation?

The request is presented at CCG's Adaptations Panel. The Adaptations Panel will then recommend the most appropriate solution to meet your needs.

As well as an assessment from the OT, prior to the Adaptations Panel, you may be visited by a member of the Tenancy Services team in order to assess your home/ family set-up. The Tenancy Services team will offer housing advice and answer any questions you may have with regards to your referral for an adaptation.

Making a Request for Adaptations

The OT or Adaptations Panel may decide that adapting your home may not be the best option to meet your long term needs. They will consider other possible solutions, which may include moving to a more suitable property which will meet your long term needs.

If your request for an adaptation is not approved, the Adaptations Panel will confirm their decision to refuse the request by letter. Please don't hesitate to contact CCG on 0300 123 8084 to discuss the Panel's decision.

What happens next if the request for a Major Adaptation is approved?

The Adaptations Panel will confirm their decision to approve the request by letter. If you are required to pay a service charge, you will be expected to complete and return the 'Adaptations Service Charge Form' that's included with the decision letter. (Please see the 'Adaptations Service Charge Factsheet' for more information on Adaptations Service Charges). Once the form is returned, CCG will arrange for a surveyor/contractor to visit your property to assess the work needed. CCG will then purchase the adaptations equipment, and a convenient installation date will be arranged.
